## AMENDED OFFICER RECOMMENDATION

AR063: AMENDED OFFICER RECOMMENDATION VOTING REQUIREMENT: ABSOLUTE MAJORITY

#### **THAT Council:**

- (1) ADOPT the Reviewed Register of Delegations & Authorisations 2019, subject to the following amendments:
  - (a) Delegation 2019:030 <u>Caravan Parks</u>, Control of Vehicles & Camping on Public Land.

The following designated persons are authorised to act under Part 3, Section 17 (1)(a) of the Caravan Parks and Camping Grounds Act, 1995:

- Manager Building, Health & Compliance, and
- Environmental Health Officers;
- to enact delegated powers:
- (b) Delegation 2019:008 Legal Proceedings

### **Delegated Power:**

- 1. Authorise Legal Expenses for Council Members, Employees and Volunteers.
- 2. Enact legal proceedings, <u>represent</u> and authorise persons to represent the City in a Court.
- 3. Authorise persons to administer any or all of the above functions.
- (2) RESCIND the Land Fill Subsidy Scheme (noting the policy position and conditions are detailed in the delegation titled: 2019:009 Grant Funding, Donations, Sponsorship and Subsidies).

### Reason (S Jamieson):

- Delegation 2019:030 Caravan Parks, Control of Vehicles & Camping on Public Land.
  - o The Caravan Parks and Camping Grounds Act 1995 does not contain a head of power to delegate the appointment of authorised persons to the CEO.
  - A delegated authority is required for Environmental Health Officers to enter and inspect caravan parks.
- Delegation 2019:008 Legal Proceedings
  - Authorises the designated positions listed to represent the City of Albany by default, being: Chief Executive Officer, Executive and the Manager Governance & Risk | Manager Finance | Manager Ranger & Emergency Services | Team Leader Ranger Services | Manager Building, Health and Compliance | Senior Planning and Development Compliance Officer.
