By submitting an Expression of Interest, you are confirming that your group/club will abide by the following terms and conditions:

- Your group/club can guarantee delivery of a calendar to each house within the nominated delivery zone between **25 November 22 December 2024.**
- The group/club has appropriate public liability insurance for their members participating in this type of fundraising activity.
- If children are engaged:
 - children will be appropriately supervised by an adult with the appropriate police clearances; and
 - children must be a minimum of 10 years of age.
- Vehicles will be operated in accordance with state law, noting vehicles to be registered, passengers to wear seat belts, not ride in trailers or on back of utes or trailers.
- The group/club has a group/club bank account to receive the donation upon completion of the activity.

Acknowledgement that the group/club is responsible for:

- Ensuring appropriate health and safety precautions will be taken, as a minimum: wearing of high-vis, sun protection, briefing on safety precautions on safe road use; and
- The supply of all required vehicles, supervising adults, logistical support and health and safety equipment.
