

In Brief:

- Following a competitive tender process, and approval of additional funds, Council approval is sought to award Tender C25029 Millbrook Road (SLK 10.6 – 12.5) Reconstruction & Widening.
- 3. Six (6) complying tenders and one (1) alternative tender were received with Tenderer A being the recommended contractor.
- 4. The budget is required to be increased by \$20,000 to award to the successful tenderer and provide adequate contingency. This means the current budget will be increased from \$1,451,100 to \$1,471,000.

DIS455: AUTHORISING OFFICER RECOMMENDATION 2

THAT Council AWARD Contract C25029 Millbrook Road (SLK 10.6 – 12.5) Reconstruction & Widening to the tenderer recommended by the evaluation panel, as detailed in the Confidential Briefing Note attached to this report.

BACKGROUND

- 5. Millbrook Road runs between Albany Highway and Chester Pass Road over a distance of 16km. City of Albany has previously undertaken works on Millbrook Road to bring the road up to contemporary standards and this project will extend the upgrade of the road a further 1.9km towards Albany Highway.
- 6. The proposed works involve the widening and reconstruction of Millbrook Road from a nominal 6.0m seal width to a 7.0m seal width plus 1.2m wide shoulders (0.8m sealed, giving a total sealed width of 8.6m).
- 7. Grant funds have been secured from the State Government through the Road Project Grants to complete these proposed works in 2025/26.

DISCUSSION

- 8. This project was advertised in early September 2025 and closed on 29 September 2025. A total of seven submissions were received.
- 9. A total of fifty-four (54) tender documents were issued by City of Albany during the current tender period.
- 10. Six (6) complying tenders and one (1) alternative tender were submitted on or before the stipulated closing date and time.

11. The tender was evaluated using the weighted attributes methodology. This method scores the evaluation criteria and weights their importance to determine an overall points score for each tender. The criteria are tabled below:

12. The following table summarises the tenderers and their weighted scores:

- 13. Four of the six tenderers claimed and were eligible for the Buy Local Policy reduction.
- 14. Based on the evaluation scoring, Tenderer A is the preferred tenderer. It is therefore recommended that their tender be accepted and the contract awarded.

GOVERNMENT & PUBLIC CONSULTATION

15. A request for tenders was published in *The West Australian* on Monday 1st September 2025 and *The Albany Extra* on Tuesday 2nd September 2025.

STATUTORY IMPLICATIONS

- 16. Regulation 11 of the Local Government (Functions and General) Regulations 1996 (Regulations) requires Council to publicly tender if the contract is, or is expected to be, more, or worth more than \$250,000.
- 17. Regulation 18 of the Regulations outlines a number of requirements relating to choice of tender. Council is to decide which of the acceptable tenders is the most advantageous to Council. It may also decline to accept any tender.
- 18. Regulation 19 of the Regulations requires Council to advise each tenderer in writing the result of Council's decision.
- 19. Voting Requirement is **Simple Majority**.

20. Council's *Purchasing Policy (Tenders & Quotes)* and *Buy Local Policy (Regional Price Preference)* are applicable to this item.

FINANCIAL IMPLICATIONS

- Current funding for this project has been received from the WA State Governments Road Project Grants funding, and City of Albany municipal funds as allocated in the 2025-2026 budget.
- 23. The current budget allocated is insufficient to award the tender as well as provide adequate contingency funding for the construction.
- 24. More detailed information regarding the financial implications is contained in the Confidential Briefing Note.

LEGAL IMPLICATIONS

There are no legal implications associated with this item.

ENVIRONMENTAL CONSIDERATIONS

- Some vegetation clearing is required to be undertaken as part of this contract to accommodate the proposed road widening.
- 27. City of Albany has submitted an application to Department of Water and Environmental Regulation to clear the required vegetation.

ALTERNATE OPTIONS

- 28. The options are:
 - a) Council may elect to accept the budget review and recommended tender; or
 - b) Accept the budget review, and award to a different tenderer (providing reasons); or
 - c) Not approve the budget review or tender.

CONCLUSION

- 29. The City has undergone a competitive process in line with the relevant legislation and established policies.
- 30. It is recommended, based on the evaluation scoring, clarification and financial check processes that the tender be awarded to Tenderer A.



BACKGROUND

- 5. Campbell Road is a District Distributor Road forming part of an important link between Albany CBD and the suburb of Spencer Park.
- The pavement is nearing the end of its serviceable life, and the proposed work involves reconstructing the road pavement and surfacing, along with associated piped drainage and concrete footpaths, linking Angove Road to the north and North Road to the south.
- Design and specification documentation was prepared by the City of Albany to the stage of 'Issued for Tender'.
- 8. Subject to award, construction is expected to commence in January 2026 with completion in late March 2026.
- 9. The tender was open from 27 August 2025 to 16 October 2025.

DISCUSSION

- 10. A total of fifty-eight (58) tender documents were issued by City of Albany.
- 11. Three (3) complete tender documents were submitted on or before the stipulated closing date and time (one Contractor provided a conforming tender and an alternative tender).
- 12. The tenders were evaluated using the weighted attributes methodology. This method scores the evaluation criteria and weights their importance to determine an overall points score for each tender. The criteria are tabled below:

- 14. All Tenderers claimed the *Buy Local Policy* reduction.
- 15. Tenderer A ranked highest with the highest score of 643.00.
- 16. From the evaluation scoring Tenderer A are the preferred tenderer and consequently it is recommended that their tender be accepted and the contract be awarded.

GOVERNMENT & PUBLIC CONSULTATION

17. A request for tenders was published in *The West Australian* on Wednesday 27th August 2025 and *The Albany Extra* on Friday 29th August 2025.

- 20. Regulation 19 of the Regulations requires Council to advise each tenderer in writing the result of Council's decision.
- 21. Voting Requirement is Absolute Majority.

- 23. The value of this tender is in excess of \$500,000 and therefore Council approval is required as this exceeds the CEO's delegation.

- 26. More detailed information regarding the financial implications are contained in the Confidential Briefing Note.
- 27. Funding for this project has been received from the Department of Transport's Road Project Grant (RPG) program as allocated in the 2025-2026 budget.
- 28. An additional \$240,000 is being requested for this project to enable contract award and completion, providing sufficient funds to cover contingencies.
- 29. The additional funds are being requested via a transfer of \$240,000.00 from the 'Roadworks and Drainage Reserve' account 13339.
