Councillor Sutton recently attended the funeral service for Mr Alan Coyne. Mr Coyne was a great spokesman for the local Noongar community. Councillor Sutton also raised the issue of legalising or decriminalising cannabis, in an effort to reduce the addiction levels to methamphetamines.

Councillor Doughty recently attended a number of school graduation ceremonies for smaller independent schools such as Comet and Alta 1. In Brief:

- Council is requested to consider the renewal of lease to Terry Hulkes over Lot 17 Cheyne Road, Cheyne Beach for accommodation associated with the commercial fishing industry at Cheyne Beach.
- The previous 5 year lease expired on 31 July 2019. During the term of the lease the tenant was required to construct an accommodation building, as part of the development approval. While the tenant had developed the site a dwelling had not been completed.
- City Officers have been working with the tenant to satisfy the outstanding development condition. A further development approval and building permit have recently been issued in October 2019.
- It is proposed to include a development special condition that the tenant must complete the accommodation building to meet all lease, planning and building conditions within the initial 4 year term of the lease.
- It is recommended the new lease is approved.

- j) Pursuant to Section 18 of the *Lands Administration Act* 1997, the Minister for Planning, Lands and Heritage consent being obtained.
- k) Pursuant to Section 3.58 of the Local Government Act 1995 advertising requirements.
- I) Lease being consistent with City Policy Property Management (Leases and Licences) and Cheyne Beach Planning Policy.

BACKGROUND

- 2. Lot 17 Cheyne Road is located within Crown Reserve 878 Cheyne Beach.
- 3. The reserve is under management order O202922 issued to the City of Albany with the power to lease or licence for any term not exceeding 21 years subject to the consent of the Minister for Planning, Lands and Heritage. The current purpose of this reserve is "Recreation, Camping, Holiday Accommodation, Accommodation Associated with the Fishing Industry, Fire Station and Supporting or Beneficial Communications Operations".
- 4. The reserve currently hosts 29 holiday accommodation leases along Baxteri Road, 6 leases for accommodation associated with the commercial fishing industry along Cheyne Road and 2 commercial fishing licences for access and net drying operations. The City's fire shed is situated on Lot 15 within this reserve.
- 5. In November 2012 Council approved a new 5 year lease to Terry Hulkes to enable the development of the site for fishing accommodation when fishing from Cheyne Beach. The term of the lease was considered appropriate to develop the site and the City was reviewing leases in coastal locations that may be subject to erosion, inundations and other adverse coastal conditions.
- 6. The lease commenced 1 August 2014 and expired 31 July 2019. The tenant continues to occupy under lease holding over provisions. Current annual lease rental payable to the City, being \$2,819 plus GST.
- 7. The tenant has requested a new lease for a maximum term in order to complete the accommodation building and secure long term tenancy to continue his commercial fishing activities at Cheyne Beach.

DISCUSSION

Development approval

- 8. To satisfy lease conditions and development approval the tenant was required to construct an accommodation building and associated infrastructure on the land to support the commercial fishing activities. The tenant was also responsible for providing adequate electricity supply, adequate potable water supply, an effluent disposal system and parking.
- 9. A development approval and building permit was issued in 2015 for the works. Noting the building permit was extended in February 2017.
- 10. While the tenant has developed the site with access driveway, work shed, rain water tank and septics, an accommodation building has not been completed within the term of the lease.
- 11. City Officers have been working with the tenant to satisfy the outstanding conditions prior to progressing a new lease. This has included discussions around a range of suitable accommodation buildings.
- 12. A way forward has been agreed and a new development approval (P2190530) and building permit (163789) have been issued in October this year, in accordance with the Cheyne Beach Planning Policy.

<u>Lease</u>

- 13. A lease can be considered with commercial fisherman seeking fisherman accommodation at Cheyne Beach, provided they meet the following requirements:
 - a. The tenant is actively engaged in the Cheyne Beach commercial fishing industry;
 - b. The tenant holds a current commercial fishing licence issued by the Department of Fisheries Western Australia; and
 - c. The tenant will use the fisherman accommodation within the lease area for own or staff use only.

- 14. It is noted that the tenant has complied with the above lease preconditions.
- 15. It is recommended the lease term be an initial term of 4 years with two further options of 6 years and 10 years (20 years in total). The 20 year term is consistent with other commercial fishing leases at Cheyne Beach.
- 16. The initial 4 year term is based on the period allowable for a building permit of 2 years, with consideration for one 2 year extension.
- 17. Importantly, the lease will include a special condition that the tenant must build the accommodation associated with the tenant's permitted use of the leased area within the initial 4 year term.
- 18. In carrying out the construction of the accommodation building the tenant must comply with the terms of the lease, the Cheyne Beach Planning Policy, the building and planning approvals and the Management Order over the land.
- 19. If the tenant fails to comply the City may end the lease with no further terms considered.
- 20. As such the tenant will be required to vacate, remove all infrastructure and make good the land.

21. The table below summarises the essential terms of the proposed lease:

- 22. The tenant has agreed in principle with the above position, subject to Council and Department of Planning, Lands and Heritage approval.
- 23. The remaining terms of the lease agreement will be developed in line with City Policy Property Management (Leases and Licences).

GOVERNMENT & PUBLIC CONSULTATION

- 24. The Department of Planning, Lands and Heritage will be consulted as it is a requirement of Section 18 of the *Land Administration Act* 1997 that the Minister's consent is obtained.
- 25. Section 3.58 of the *Local Government Act 1995* defines the requirements for the disposal of property, including leased land and buildings. The Act requires the following:
 - a. A local government must give local public notice of the proposed lease inviting submissions from the public, for a period of two weeks.
 - b. Any submissions are to be considered by Council and their decision with regard to those submissions, to be recorded in the minutes.
 - c. A local government can then proceed with the lease.
- 26. The new lease will be advertised to comply with the requirements of Section 3.58 of the *Local Government Act 1995.*

STATUTORY IMPLICATIONS

- 28. Section 18 of the *Land Administration Act 1997* states that a person shall not assign, sell, transfer or otherwise deal with interests on Crown land, create, or grant an interest in Crown land without the prior approval in writing of the Minister for Planning, Lands and Heritage.
- 29. As this is Crown land, under Management Order held by the City, the Minister's consent will be sought.
- 30. The *Aboriginal Heritage Act 1972* applies to any place or object of importance to persons of Aboriginal descent and Section 17 of this Act makes it an offence to destroy, damage or alter in any way an Aboriginal site or object. This Act applies to known and unknown sites.
- 31. In past discussions with the local Noongar community regarding the Cheyne Beach area, including visits on site, it is known to officers that there are areas in this locality of significance to the Noongar community. A full Aboriginal Heritage Survey was undertaken in 2015 to consider a range of future proposals in the Cheynes locality to manage any risk of disturbing Aboriginal cultural heritage.
- 32. Any future development needs to be considered in the context of the recommendation of the Heritage Survey. It is noted that these matters have been considered as part of the development application and approval has been provided for the proposed development.

POLICY IMPLICATIONS

- 33. Council adopted a revised Property Management (Leases and Licences) Policy in July 2017.
- 34. The Policy aims to ensure that all requests for leases and licences will be treated in a fair and equitable manner using open and accountable methodology and in line with statutory procedures.
- 35. The recommendation is consistent with the Policy.
- 36. The proposed lease complies with the City's Cheyne Beach Planning Policy.

RISK IDENTIFICATION & MITIGATION

37. The risk identification and categorisation relies on the City's Enterprise Risk and Opportunity Management Framework.

FINANCIAL IMPLICATIONS

- 38. All costs associated with the lease documentation and development works are the responsibility of the tenant.
- 39. The lease rental of \$2,950 per annum plus GST will be placed into the Cheyne Beach Improvement Reserve for the purpose of facilitating community maintenance and enhancement projects in the Cheyne Beach locality.

LEGAL IMPLICATIONS

40. The Deed will be prepared by City's lawyers with enforceable terms and conditions, at the tenant's expense.

ENVIRONMENTAL CONSIDERATIONS

- 41. The City is currently considering a Coastal Hazard Risk Management and Adaption Plan (CHRMAP) to help plan the management of future coastal erosion at Emu Point to Middleton Beach.
- 42. It is noted that Cheyne Beach is not in the current plan however the new lease does provide an opportunity to ensure the tenant is aware of potential impact of coastal erosion inundation, sea level rises and other adverse conditions given the proximity to the coast.
- 43. Further, indemnification clauses will be included in the lease such that the City is not liable for any loss or damage by the tenant by any reason arising from adverse coastal processes.

ALTERNATE OPTIONS

- 44. Council may:
 - a. Approve the new lease request; or
 - b. Decline the request.

- 45. Should Council decline the lease, the tenant will need to work with the City to find an alternate location should he wish to continue commercial fishing activities at Cheyne Beach. This may result in early closure of fishing operations given the limited availability of suitable land and the cost to relocate.
- 46. The tenant may be required to vacate the property, demolish and remove all infrastructure and make good the land.

CONCLUSION

- 47. Terry Hulkes, the existing tenant over Lot 17 Cheyne Road, Cheyne Beach has requested a new lease to continue commercial fishing operations from Cheyne Beach.
- 48. To comply with planning and building approvals the tenant must complete an accommodation building within the initial 4 year term of the lease. Non-compliance with this special condition in the lease will give the City the right to end the lease.
- 49. Given the proximity of the site to the coast the tenant agrees to occupy the site at their own risk and indemnifies the City against any loss or claim resulting from occupation of the site.
- 50. The tenant has met all of the lease preconditions and the proposed lease is in accordance with the Management Order over the land.
- 51. Taking into consideration tenant investment in developing the site to date and agreement to comply with the lease, planning and building conditions it is recommended that a new lease be granted for a term of 4 years with two further options of 6 years and 10 years (20 years in total) be supported.

BACKGROUND

- 2. In 2013 an independent review was conducted to improve support to the Volunteer Bush Fire Brigades and overall Emergency Management.
- 3. At the time it was recommended that:
 - a. The current "individual brigade constitution approach" should remain for brigades in the <u>medium term</u> as this arrangement suits the wide variation in commitments and time across the city.
 - b. In the long-term, the issue is to be investigated with the view to achieving consistency across brigades.
- 4. It is has been identified by both City Officers and Volunteer Bush Fire Brigade leaders that a Bush Fire Brigades Local Law should be progressed to:
 - a. Achieve consistency across brigades;
 - b. Promote a common understanding of accountabilities for both City Officers (Administration) and Brigade Officers and members.
- 5. As detailed in the consultation section of the report, consultation been conducted over a number of years by City Officers, working with brigade Fire Control Officers and members.

DISCUSSION

- 6. To initiate the local law process, Council must first resolve to MAKE the Local Law.
- 7. Section 3.12 of the *Local Government Act 1995* (the Act) requires the person presiding at a Council meeting ensures the purpose and effect of the proposed local law is given.
 - a. **Purpose:** The purpose of the principal local law is to provide for the regulation, control and management of City of Albany Volunteer Bush Fire Brigades within the district of the City of Albany.
 - b. **Effect:** Formalise the administrative processes will govern the establishment, management, roles and responsibilities of bush fire brigades.
- 8. Simplified outline of the proposed local law:
 - a. This local law is about the establishment, management, roles and responsibilities and cancellation of bush fire brigades within the municipality of the City of Albany.
 - b. **Part 1** includes preliminary provisions including the commencement date and definitions of the terms used throughout this local law.
 - c. **Part 2** provides for the establishment and cancellations of bush fire brigades by the City of Albany. It also includes provisions for the transition of bush fire brigades existing prior to the date of effect of this local law.
 - d. **Part 3** defines the objectives of bush fire brigades and details the responsibilities of the City of Albany and the Bush Fire Advisory Committee. It also addresses how the local government considers the appointment of bush fire control officers, pursuant to section 38 of the Act.
 - e. The statutory powers and duties of bush fire control officers are defined in the Act. This part allows for the local allocation of those duties (as per s.62(1)(a) of the Act).
 - f. The managerial role of the Chief Bush Fire Control officer is also defined.

- g. Part 4 defines the roles and responsibilities of brigade members.
- h. Part 5 addresses the funding of bush fire brigades by the local government.
- i. **Part 6** provides that bush fire brigades, and bush fire brigade members are to comply with the Rules Governing the Operation of Bush Fire Brigades as contained in Schedule 1.
- j. Schedule 1: Contains the Rules Governing the Operation of Bush Fire Brigades.
 - (i) **Part 1** contains the definitions of the terms used in the Schedule.
 - (ii) Part 2 provides for the rules governing the Committee of the bush fire brigade including the roles and responsibilities of the Committee, membership and termination of membership of the Committee, and the rules applicable to the conduct of Committee meetings.
 - (iii) **Part 3** defines the roles and responsibilities of brigade officers, including Committee members, and the hierarchy of command at a fire.
 - (iv) **Part 4** provides for the conditions of membership of a brigade and determines the membership application process.
 - (v) Part 5 provides for the rules that govern the suspension and termination of membership of a bush fire brigade member, including the member's right of defence.
 - (vi) **Part 6** contains the rules governing the conduct of meetings of the bush fire brigade, including ordinary meetings and annual general meeting.
 - (vii) **Part 7** contains the rules relating to financial management, declaration of interest and the dispute resolution process.
 - (viii) **Part 8** is about notices and the rules regarding proxy votes, when a brigade member is unable to attend a meeting.

GOVERNMENT & PUBLIC CONSULTATION

- 9. City of Albany Fire Brigade Member Consultation:
 - a. Consultation has been facilitated over a number of years by City Officers, working with brigade Fire Control Officers and members.
 - b. Formal consultation initiated for the proposed local law on 15 January 2019.
 - c. The proposed local law was presented to a number of working groups/consultation meetings and brigade sector meetings.
 - d. On 6 May 2019, a briefing was given to the Bush Fire Advisory Group. At this meeting:
 - Brigade Member: R Lynn presented a short overview of the progress of the creation of the City of Albany Bush Fire Brigade Local Law.
 - Explained the process for the making of a local law, including the time required for public consultation.
 - e. On 1 October 2019, a report regarding the progress and status of the draft local law was prepared for the Bush Fire Advisory Committee.
 - f. The Committee was advised by City Officers that the local law is ready to be presented to Council.
- 10. Post Council resolution to make the local law:
 - a. A copy will be formally tabled at the next City of Albany Bush Fire Advisory Committee (BFAC) and Local Emergency Management Committee (LEMC);
 - b. A copy of the proposed Local Law will be forwarded to the Department of Local Government; and

- MEETING
 - c. In accordance with section 3.12 of the Act, the City will give State-wide publication of its intention to make the Local Law and will invite submissions from the public.

STATUTORY IMPLICATIONS

- 11. Making a local law needs to be done in accordance with section 3.12 of the Act.
- 12. The resolution of Council to make the local law must be carried by Absolute Majority.
- 13. After making the local law a copy must be provided to the Minister for Local Government.

POLICY IMPLICATIONS

14. There are no direct policy implications related to this report.

LEGAL IMPLICATIONS

18. Bush Fires Act 1954, states in part:

41. Bush fire brigades

(1) For the purpose of carrying out normal brigade activities a local government may, in accordance with its local laws made for the purpose, establish and maintain one or more bush fire brigades and may, in accordance with those local laws, equip each bush fire brigade so established with appliances, equipment and apparatus.

62. Local government may make local laws

- (2) A local government may make local laws in accordance with subdivision 2 of Division 2 of Part 3 of the Local Government Act 1995 for and in relation to
 - (a) the appointment, employment, payment, dismissal and duties of bush fire control officers; and
 - (b) the organisation, establishment, maintenance and equipment with appliances and apparatus of bush fire brigades to be established and maintained by the local government; and
 - (c) any other matters affecting the exercise of any powers or authorities conferred and the performance of any duties imposed upon the local government by this Act.

- 2. Governor's consent has to be sought prior to Council adopting the proposed local law.
- 3. On 25 September 2018, Council resolved to remake the *City of Albany Jetties, Bridges & Boat Pens Local Law 2005* (As amended).
- 4. On 28 May 2019, Council resolved to MAKE the proposed new local law, noting the requirement that prior to presentation for <u>final adoption</u>, in accordance with section 3.6 of the Local Government Act 1995 (the Act), the Governor's consent must be sought.

DISCUSSION

- 5. The previous local law, which will be replaced by this proposed local law was approved by the Governor and Gazetted on 10 February 2004.
- 6. The Governor's approval extended the area of application to areas located outside of the City of Albany's district, such as the:
 - a. Albany Town Jetty Precinct; and
 - b. Emu Point Boat Pens.
- 7. The proposed local law updates areas and location descriptions.
- 8. On 13 November 2019, received advice from the Dept. of Local Government, being:

"Once the City has finalized the draft of the local law and prior to submitting the final draft to council for adoption, the City should send a letter to the Minister formally requesting the Governor's approval.

This application should include:

- A copy of the final draft of the local law;
- Diagrams of the lots specified in clause 1.3; and
- A council resolution authorizing the City to make the application (either directly or via an appropriate delegation).

When this request is submitted, the Department will prepare a suitable application to the Governor on the City's behalf. Once the Governor's approval is obtained, the City will be notified and the final draft can be submitted to the council for adoption under section 3.12(4) of the Act."

GOVERNMENT & PUBLIC CONSULTATION

- 9. **Stakeholder engagement:** The local law making process provided members of the public and government departments to have their say on the proposed local law and their relevance within the community.
- 10. A copy of the Local Law was forwarded to the Department of Local Government and the Department of Transport on 20 June 2019.
- 11. Ongoing consultation has been conducted with the Department of Transport and the Department of Local Government with the latest advice being received on the 13 November 2019.

	The easiest way of achieving the abovementioned clarification of application of the Local Law would seem to be to include a specific opening provision under Clause 1.3 Application, with the wording
	"This local law applies to the jetties, bridges, boat pens and swimming enclosures under the control of the City of Albany", prior to addressing the extension of application beyond the City of Albany's district.

Such a provision would also confirm what is understood to be your intended application of the local law to cover all jetties etc. under the control of the City.

I am not aware of any overarching provisions of the Local Government Act, but the current wording of the draft would seem to limit the application of the local law to the specific areas identified within the 1.3 Application clause (which do not include any bridges or swimming enclosures).

With respect to the application of the local laws beyond the City's district, the reference to the Albany Waterfront Marina Precinct should be deleted as there are no jetties, bridges, boat pens or swimming enclosures under the care control or management of the City on either of the Lots 1583 or 1584.

With respect to the Emu Point reference, the City's facilities only occupy a portion of Lot 350 with DoT facilities and areas under control comprising the balance.

It is therefore suggested that the wording be amended by adding the passage "on land leased to the City of Albany by the Minister for Transport pursuant to the Marine and Harbours Act 1981 on portion of" between the words "located" and "Lot 350" in substitution of the word "at" in line 1 of item (a).

Comment: Agreed, local law amended accordingly.

You may also want to broaden this provision to refer to both jetties and boat pens noting that the City also controls a boat launching ramp with finger jetty, a universal access jetty and boat lifter jetties at this location.

If the City needs this provision extending the application of its local laws at Emu Point, it may also need to consider the situation elsewhere as several jetties, ramps and the Ellen Cove swimming enclosure that are under the care control or management of the City extend beyond low water mark and are located within or partly within the declared Port of Albany under the control of the Southern Ports Authority.

Comment: Agreed, local law amended accordingly.

Although the 2015 Ward Boundary Change maps (DP 405587) generally depict the Low Water Mark as the seaward boundary of the LGA area, **mapping on Landgate's viewer indicates that the City of Albany LGA area** extends seaward so as to encompass the whole of the area to the Coastal Waters boundary.

Comment: Agree, Request the Department of Local Government to confirm the boundaries, as part of the preparation for consent by the Governor.

Clause 1.5 Definitions

Department of Transport:
 With respect to the definition "commercial vessel" it would seem that the only reference to commercial vessel within the draft local law is within the definition of "vessel". It is suggested that the "commercial vessel" definition and the corresponding use of the term within the definition of "vessel" be deleted as it appears to serve no real purpose.
 Comment: Agree, amended accordingly.

Proposed Local Law	Comments:
Clause 2.1 Use of jetty bridge or land	Department of Transport: 2.1 (2)(b) should in our view be deleted as the closure referred to under section 6 of the Jetties Act 1926 only relates to a public jetty, whereas jetties owned by a LGA fall under the category of a private jetty. (The inclusion of this reference in your current local law was to recognise that the previous Town Jetty, which was a public jetty, had been leased /licenced under the LGA's control).
	Comment: Amended, clarified this applies only to structures owned by the local government, amended accordingly.
	Noting the definition of jetty is clarified by stating the structure must be under the care, control and management of the local government.
Clause 2.10 Vehicles on Jetty	Department of Transport: With respect to 2.10 (1) and (2), you may want to include a qualification with respect to the use of boat launching ramps as they fall within the definition of a jetty.
	Comment: Agree, definition added and sub-clause 2.10(2)(c) added.
Clause 2.11 No fishing from jetties or swimming enclosures designated for Swimming	Fishers with Disabilities - Volunteer The Ellen Cove Jetty is used by fishers and provides wheel chair access and easy access for the mobility impaired.
	Comment: Recommend support amendment, clause 2.11 (1) No fishing from jetties or swimming enclosures designated for Swimming, amended to include subclause: Subclause (1) does not apply to the Ellen Cove Jetty.
Clause 3.1 – Licences issued under previous local law	Department of Local Government:
	The City may wish to add a transitional clause in relation to licences or permissions granted by the City under the previous local law. In particular, it appears that the City's current local law allows licences to live in boats, while the draft local law will prohibit this.
	If anyone is currently living in a boat under a licence issued by the City, the City may wish to consider what status those licences will have under the new law.
	Comment: No current tenants live aboard. Therefore, not applicable.
Clause 3.4 – Entry onto boat for purpose of inspection	Department of Local Government: Clause 3.4(2)(a) provides that an authorized person may board a vessel at any time to inspect mooring lines. Currently, the Local Government Act 1995 does not provide local governments with any general right to enter vehicles or private property.
	While the Act grants some powers of entry, these powers are limited to specific circumstances.
	It appears that a similar clause was present in the City's original version of the City's 2006 jetties local law. However, the Parliament's Delegated Legislation Committee objected to the clause and the City deleted it in a subsequent amendment.
	It is suggested that clause 3.4(2)(a) be deleted, otherwise the Committee is likely to object to it in a similar manner.
	Comment: Agree, local law amended.
Clause 3.6 General Prohibitions	Department of Transport: In 3.6 (2) the reference to hull cleaning in the pen system and reference to such hull cleaning only being undertaken within the licensee's pen is not generally supported. particularly, with respect to any pens or any jetties that are within a Departmental Area as defined within the Marine and Harbours Act (includes the Emu Point facility).

Proposed Local Law	Comments:
	DoT does not allow/support the cleaning of vessel hulls (or any major repairs to the external surface of a vessel or its equipment where there is risk of material ending up in the water) within any of its boat harbours or mooring pens, whether by chemical means, high pressure cleaning, or other mechanical means. This is due to the inherent risk of pollution/contamination and spread of marine pests in addition to a potential nuisance being caused to adjacent penholders.
	Instead, DoT requires such hull cleaning and maintenance activities to be carried out at a shore based vessel maintenance facility where all waste can be isolated, collected and disposed of at approved land fill sites.
	It is noted that a boat lift facility and vessel maintenance area exist at the Emu Point Boat Harbour facility that could facilitate such out of water hull cleaning.
	(The City's lease of the area occupied by its pens and other jetties at Emu Point pursuant to the Marine and Harbours Act also contains obligations not to pollute or contaminate the leased area or allow such pollution or contamination by others.
Clause 3.9 - Impoundment of vessel	Comment: Concur, local law amended accordingly. Department of Local Government: Clause 3.9(h) of the local law provides that if a licensee breaches any provision of the local law, their vessel may be impounded in accordance with the Act.
	Currently the Act only allows for the impoundment of vehicles in circumstances when the vehicle is obstructing a public place, causing a hazard to public safety or the presence of the vehicle is unlawful.
	While paragraph (h) will apply for all breaches of the local law, this does not necessarily mean that all breaches of the local law will allow impoundment under the Act.
	The City should keep this in mind and ensure it has appropriate procedures in place so it doesn't impound a vessel in the wrong circumstances.
	Comment: Noted. Any action is protected by clause 4.9 Objection and appeal rights.
Right of review for license decisions.	Department of Local Government: Currently, the local law doesn't provide for any right of review for decisions made under the local law.
	The City may wish to add a clause setting out a right of review for decisions relating to consent and licenses.
	While the City isn't obligated to do this, the absence of a right of review may be raised as an issue by the Parliament's Delegated Legislation Committee.
	It is noted that the City's current local law lacked such a clause and this wasn't raised as an issue when it was considered in 2006. However, this can't be taken as a guarantee of how the current Committee will consider the matter, since it isn't bound by decisions made by the Committees of previous Parliaments.
	Comment: Agree, right of review clause added, clause 4.9 and the definition for regulations.
	 4.9 Objection and appeal rights When the local government makes a decision as to whether it will— (a) grant a person a licence under this local law; or (b) renew, vary, or cancel a licence that a person has under this local law, the provisions of Division 1 of Part 9 of the Act and regulation 33 of the Regulations shall apply to that decision.

13. Delegation to City Officers must be resolved by Absolute Majority.





BACKGROUND

- 2. This Local Law was amended in 2017 with the adoption of the City of Albany Dog Local Law 2017.
- 3. On 25 September 2018, Council resolved to remake the *City of Albany Animals Local Law* 2001 (As amended) and give consideration to the Officer Recommendation, being:

Animal Local Law:

That the local law be fully reviewed, the current local law repealed and a new local law made.

That:

- (1) The provision to allow the keeping of bees be considered in the proposed new law.
- (2) Horse exercise areas and associated management conditions be reviewed.
- (3) Allow for the keeping of poultry with conditions be considered.
- (4) Animal control, for all animals in public places is extended to address:
 - Fouling of public places; and
 - Ensuring appropriate control.

(5) That the review of the Animals Local Law is led by Health Team, noting the head of power for this local law is the new Health (Miscellaneous Provisions) Act 1911.

Repealed Cat Local Law:

That the local law remain repealed, noting that additional control measures could be facilitated through an updated Animals Local Law.

Dog Local Law:

There is no need to either amend or repeal this Local Law.

DISCUSSION

- 4. The purpose of this Local Law is to provide for the regulation, control and management of the keeping of domestic animals and birds, large animals, miniature horses and pigs.
- 5. The previous local law, will be replaced by this proposed new local law.
- 6. Feedback received on the current Local Law is detailed in the Community Consultation section of the report.

GOVERNMENT & PUBLIC CONSULTATION

- 7. **Stakeholder engagement:** The local law making process provided members of the public and government departments to have their say on the proposed local law and their relevance within the community.
- 8. A copy of the proposed Local Law was forwarded to the Department of Local Government for comment.
- 9. Additional consultation will be conducted during the public consultation period that will be extended from the prescribed period of 6 week, noting the festive season, to close by the end of February 2020.
- 10. **Stakeholder engagement (2018):** The review process enabled members of the public to have their say on the current local laws and their relevance within the community.
- 11. This opportunity also provided the opportunity to identify new matters that could be dealt with through the development of, or amendment to a local law.

- 12. Public Notices of the review was posted on the City's:
 - a. Website and social media feeds; and
 - b. Public Library Notice Boards.
- 13. In accordance with the Act, local government notices were advertised in The West, April 7 to 8, 2018, Page 100; and the Great Southern Weekender.
- 14. Consultation: All local laws were advertised for comment, with two submissions received during the consultation period.
- 15. To complement the review historic inquiries and comments specific to the City of Albany's existing local laws have been included.
- 16. An additional review of similar local laws across the sector was also conducted.

ADDENDUM

- 1. At the CCS Committee Meeting held on Tuesday 3 December 2019, City staff were requested to review the position of the Local Law relating to the keeping of pigs, keeping of bees and the keeping of poultry.
- 2. The following proposed amendment for the Keeping of Pigs, to reduce red tape for agricultural zoned properties and mitigate the impact on amenity on bordering residential zoned properties follows:

4.5 Keeping of Pigs

(1) Except for a miniature pig, no lot shall keep a pig or pigs unless every portion of the area where the pig or pigs are kept is-

- (a) greater than 200 metres from the lot boundary of the lot upon which the pig or pigs are to be situated; and
- (b) greater than 100 metres from any dwelling house, dairy or other premises where food for human consumption is prepared, stored or sold.

(2) The local government may prohibit the keeping of a miniature pig on any land or state the conditions under which they may be kept.

(3) A person may keep one miniature pig in any residential area provided it is registered with the local government and the approved annual registration fee is paid.

- (4) The occupier of any premises where a miniature pig is kept must—
 - (a) only keep a sterilised animal and retain written proof of its sterilisation;
 - (b) confine the animal on the property at all times;

(c) ensure the animal does not cause a nuisance to any neighbour regarding noise, dust or odour; and

(d) maintain documentary evidence that the animal's veterinary treatment against roundworm and tapeworm is current.

3. The following proposed amendment for the Keeping of Bees, to address concern in regards to public health issues, due to bee stings follows:

PART 6 - KEEPING OF BEES

6.1 Limitation on numbers and location of Hives

(1) A person must not keep or permit the keeping of bees on a lot except in accordance with this Part and State Legislation.

(2) A person may keep bees on a lot zoned for agricultural use.

(3) The local government may, upon written application, consent, with or without conditions, to a person keeping up to 2 beehives on a lot which is not zoned for agricultural purposes.

(4) A person keeping bees within a residential area must have undergone a responsible beekeeping training course or similar and have proof thereof.

(5) A person must comply with any conditions imposed by the local government under subclause (3).

6.2 Restrictions on keeping Bees in Hives

A person must not keep or permit the keeping of bees in a hive on a lot unless, at all times—

(a) an adequate and permanent supply of water must be provided within 10m of the beehives;(b) the beehive is kept—

- (i) at least 10m from any public place; and
- (ii) at least 5m from the boundary of the lot; and
- (iii) the beehive is screened from public view.

6.3 Bees which cause a nuisance not to be kept

(1) A person must take reasonable measures to not keep, or permit the keeping of bees, which cause a nuisance.

(2) Whenever in the opinion of the local government, the keeping of bees is causing a nuisance, the local government may give written notice to an owner or occupier requiring the removal of any bees or beehives from the lot within the time specified in the notice.

4. The following proposed amendment for the Keeping of Poultry, to reduce compliance red tape follows:

8.2 Conditions of Keeping Poultry

A person who keeps poultry or permits poultry to be kept shall ensure that -

- (a) they provide a properly constructed and securely fastened structure or coop;
- (b) all structures within which poultry are kept are maintained at all times in a clean condition;
- (c) the structure has an impervious floor to permit washing down;

(d) subject to clause (a) poultry that have been released to free-range are otherwise confined to the property; and

- (e) the poultry do not cause or be a nuisance to any person.
- (f) All feed for poultry be stored in vermin proof containers.

BACKGROUND

- 2. As part of the Local Government Act Review it was recognised that a new gift framework should be developed to provide a transparent system of accountability where members of the community can have confidence in the decision-making of their elected representatives.
- 3. On 20 October 2019, the new gifts framework, contained within the *Local Government Legislation Amendment Act 2019* came into operation.

4. Local governments were advised by departmental circular 11-2019:

Local governments must prepare and adopt a policy that relates to the attendance of council members and CEOs at events such as concerts, conferences and functions.

This policy must address the provision of tickets to events, payments in respect of attendance and approval of attendance by the local government and criteria for approval. New section 5.90A relates.

In essence, the policy deals with a council member's or CEO's attendance at events as a representative of the council. Tickets or the invitation to the event must be made to the council directly, not to the council member of CEO personally.

If a council member or CEO attends an event in accordance with the local government's policy, then no conflict of interest arises.

DISCUSSION

- 5. The purpose of this proposed policy is to establish guidelines for appropriate disclosure and management of acceptance of invitations to events or functions, or other hospitality occasions, where elected members and employees are invited free of charge, whether as part of their official duties as council or City representatives or not.
- 6. The content of the proposed policy position follows, noting the complete policy position is attached for review:

Policy Statements

A. Key issues to consider

In considering whether a benefit such as an invitation to an event or hospitality given to an elected member or an employee is a gift for the purposes of the Act and Regulations, the key issues include:

- Who is a donor, the person who is offering or giving the benefit?
- What is the value of the benefit?
- Does the elected member or employee of the benefit contribute anything of value to the donor in return for the benefit such as formally opening or speaking at the event or presenting prizes/awards?
- If so, does the value of that contribution outweigh the value of the benefit? If so, it will not be a gift for the purposes of the Act and Regulations.

B. Commercial entertainment events

Any tickets accepted by an elected member or employee without payment for any commercial entertainment event, for which a member of the public is required to pay whether sponsored by the City or not will generally be classified as a gift for the purposes of the Act and Regulations.

An exception to this is where the Mayor or his / her representative attends the event in an official capacity to perform a civic or mayoral function.

Where there is a commercial entertainment event that, in the opinion of the Chief Executive Officer, it is in the interests of the City for one or more elected members or employees to attend in order to assess and understand first-hand the impacts on the community or business, then one or more tickets for that event will be purchased for the relevant elected member or employee by the City at full cost.

C. Other commercial (non-entertainment) events

For other commercial (non-entertainment) events, such as a conference or seminar, for which a member of the public is required to pay, where the Chief Executive Officer is of the opinion that it is in the interests of the City for one or more Elected Members or

employees to attend (such as for their professional development or to undertake a function as an Elected Member or employee), then one or more registrations or other benefits for that event will be purchased for the relevant Elected Member or employee by the City at full cost to enable attendance.

If the City does not pay for the event, free registration or any other benefit (such as hospitality) given to an Elected Member or employee would be classified as a 'gift' unless the contribution of the Elected Member or employee to the event (such as by way of a paper or speaking engagement) is reasonably considered to outweigh the value of registration or other benefit given to the Elected Member or employee.

D. Community/local business events

Acceptance of reasonable and modest hospitality by an Elected Member or employee at an unpaid event run by a local community group for local business would not generally be classified as a 'gift' where the contribution by the Elected Member or employee to the event is reasonably considered to outweigh the value of the hospitality.

This is more likely where the Elected Member or employee attends the event in his or her capacity as an Elected Member or employee - preferably where the attendance has been specifically authorised by the City, but otherwise where the person is performing his or her functions as an Elected Member or employee.

E. Perceived or actual conflict

Event attendance may create a perceived or actual conflict, which may preclude council members participating or employees providing advice at a future meeting.

If the amount of an event ticket (gift) is less than \$1,000, and relates to a matter before Council, under section 5.68 of the Act, Council may allow the disclosing council member to participate on the condition that the interest, the council's decision and the reasons for that decision are recorded in the minutes.

If the amount gift is above \$1,000 the council or CEO must apply to the Minister for permission to allow the member or employee to participate.

Scope

The policy provides guidance to elected members and employees when an invitation to an event or function, or other hospitality occasion, ticketed or otherwise, is offered free of charge. It does not provide guidance on the acceptance of a tangible gift or travel contribution.

Travel and accommodation excluded: This policy does not apply to tangible gifts or money, travel or accommodation. Any contribution to travel, subject to the exceptions in section 5.83 of the Local Government Act 1995 (the Act), must be disclosed in writing to the CEO within 10 days of receipt of the contribution.

Contributions to travel costs, whether financial or otherwise are now incorporated within the definition of gift.

The following situations are specifically excluded where the event ticket (gift) is received from one of the following organisations:

- WALGA (but not LGIS)
- Local Government Professionals Australia (WA)
- Australian Local Government Association
- A department of the public service
- A government department of another State, a Territory or the Commonwealth
- A local government or regional local government

The gift is still required to be recorded on the "gift register".

GOVERNMENT & PUBLIC CONSULTATION

- 7. Public Consultation not applicable to this report.
- 8. Local government sector consultation was conducted in preparing this report, noting the proposed policy position was guided by the requirements of the Act and the policy position adopted by the City of Fremantle.

STATUTORY IMPLICATIONS

Local Government Act 1995:

9. As at 19 October 2019, section 5.90A(2), of the Act, states:

"A local government must prepare and adopt a policy that deals with matters relating to the attendance of council members and the CEO at events, including —*

- (a) the provision of tickets to events; and
- (b) payments in respect of attendance; and
- (c) approval of attendance by the local government and criteria for approval; and
- (d) any prescribed matter." Absolute Majority Required.

POLICY IMPLICATIONS

- 10. A new policy position is required to be adopted under the Act.
- 11. When preparing the policy or an amendment to the policy, the local government must comply with any prescribed requirements relating to the form or content of a policy under the act.
- 12. The CEO must publish an up-to-date version of the policy on the local government's official website.
- 13. The recent changes to gifts outlined below <u>has not changed the current code of conduct</u> <u>gift provisions relating to employees</u> (regulation 34B of the *Local Government* (Administration) Regulations 1996).
- 14. These provisions will be reviewed when section 5.51A (Code of conduct for employees) of the Local Government Legislation Amendment Act 2019 is proclaimed in 2020.

BACKGROUND

- 1. The Statement of Financial Activity for the period ending 30 November 2019 has been prepared and is attached.
- 2. In addition to the statutory requirement to provide Council with a Statement of Financial Activity, the City provides Council with a monthly investment summary to ensure the performance of the investment portfolio is in accordance with anticipated returns and complies with the Investment of Surplus Funds Policy.

DISCUSSION

- 3. In accordance with section 34(1) of the *Local Government (Financial Management) Regulations 1996*, the City of Albany is required to prepare each month a Statement of Financial Activity reporting on the revenue and expenditure of the local authority.
- 4. The requirement for local governments to produce a Statement of Financial Activity was gazetted in March 2005 to provide elected members with a greater insight in relation to the ongoing financial performance of the local government.
- 5. Additionally, each year a local government is to adopt a percentage or value to be used in Statements of Financial Activity for reporting material variances. Variations in excess of \$100,000 are reported to Council.
- 6. These financial statements are still subject to further yearend adjustments and have not been audited by the appointed auditor.

"Please note that rounding errors may occur when whole numbers are used, as they are in the reports that follow. The 'errors' may be \$1 or \$2 when adding sets of numbers. This does not mean that the underlying figures are incorrect."

STATUTORY IMPLICATIONS

7. Section 34 of the Local Government (Financial Management) Regulations 1996 provides:

- I. A local government is to prepare each month a statement of financial activity reporting on the source and application of funds, as set out in the annual budget under regulation 22 (1)(d), for that month in the following detail:
 - a. annual budget estimates, taking into account any expenditure incurred for an additional purpose under section 6.8(1)(b) or (c);
 - b. budget estimates to the end of the month to which the statement relates;
 - c. actual amounts of expenditure, revenue and income to the end of the month to which the statement relate
 - d. material variances between the comparable amounts referred to in paragraphs (b) and (c); and
 - e. the net current assets at the end of the month to which the statement relates.
- II. Each statement of financial activity is to be accompanied by documents containing
 - a. an explanation of the composition of the net current assets of the month to which the statement relates, less committed assets and restricted assets;
 - b. an explanation of each of the material variances referred to in sub regulation (1)(d); and
 - c. such other supporting information as is considered relevant by the local government.
- III. The information in a statement of financial activity may be shown
 - a. according to nature and type classification;
 - b. by program; or
 - c. by business unit.
- IV. A statement of financial activity, and the accompanying documents referred to in sub regulation (2), are to be
 - a. presented at an ordinary meeting of the council within 2 months after the end of the month to which the statement relates; and
 - b. recorded in the minutes of the meeting at which it is presented.

POLICY IMPLICATIONS

- 8. The City's 2019/20 Annual Budget provides a set of parameters that guides the City's financial practices.
- 9. The Investment of Surplus Funds Policy stipulates that the status and performance of the investment portfolio is to be reported monthly to Council.

- On 1 July 2019, the Water Corporation introduced new charges for Local Government standpipes in order to regulate the use of and pricing for water as a valuable natural resource.
- Local Governments were asked to control access to their standpipes in order to manage water usage by community and commercial users.
- Local Governments are entitled to access concessional pricing for water used for their own purposes but the Water Corporation was aware that some commercial operators were accessing Local Government-owned standpipes at concessional rates, rather than at higher commercial rates.
- Council is requested to determine if the City should facilitate or not facilitate the selling of water to community and commercial users.
- Three policy positions have been prepared for Council review in relation to requested determination.

RECOMMENDATION

 - c) Permit the use of potable water from standpipe meter number EK1800463 for residential supply only, except in a declared drought or major fire.

BACKGROUND

2. In September 2017, the Water Corporation conducted a review of fixed standpipe services in Western Australia. As part of the stakeholder consultation, City officers provided feedback that they had not experienced excessive use of City standpipes by community and commercial users, and suggested that the Water Corporation could install card systems to control use by commercial contractors.

- 3. At that time, the City owned and operated 17 standpipes, allowing access to some of them by commercial water carting contractors. There were 4 contractors who were charged \$2.50 per 1,000 litres of water. They were issued with documents to record their water usage and would submit them on an ad-hoc basis to City officers for invoicing.
- 4. In August 2018, the Water Corporation announced changes to pricing of potable water from Local Government-owned fixed standpipes in country areas, effective from 1 July 2019. LGAs were entitled to access concessional pricing for water used for their own purposes. However, high flow rate LGA standpipes (larger than 25mm) which were accessible to the public would be charged at higher commercial rates. There was, and still is, no charge for water consumption for fire-fighting purposes.
- 5. The Water Corporation asked Local Governments to re-categorise their standpipes and decide if they wanted to be in the business of selling water.
- 6. City officers identified 5 unrequired standpipes for decommissioning. They also concluded that the City should not be in the business of selling water for the following reasons:
 - a. It was not the City of Albany's core business to provide water.
 - b. Two commercial operators in Albany had already expended significant funds to install their own private standpipes and assisting other commercial operators could be viewed as inequitable.
 - c. This was perceived to be a cost shifting exercise from State Government to Local Government.
- 7. In December 2018, the Water Corporation advised LGAs to lock their dedicated fire-fighting standpipes in order to prevent public and commercial use at all times (Attachment 3). All the City's fire standpipes were padlocked in December 2018.
- 8. Standpipes are now only accessible to the City's emergency services staff together with bushfire brigade staff and volunteers. Signs were installed at fire standpipes advising the community that they were for fire-fighting and training use only. However, three commercial contractors were given keys to access water from the King River fire standpipe on Chester Pass Road as a temporary arrangement until 1 July 2019. This 40mm standpipe gave a sufficient flow rate for commercial operators. They were invoiced for their water usage only.
- 9. Contractors returned their standpipe keys in June 2019 and there has been no known access to any City-owned standpipes by community or commercial users since 1 July 2019.
- 10. The City of Albany currently operates 12 standpipes 11 for fire-fighting and 1 located at the Mercer Road depot used for public works. The Mercer Road depot standpipe is located within the secure depot compound and is only accessible to City staff and authorised contractors working on City projects.
- 11. Officers obtained quotes for solar-powered, internet-connected standpipe controller systems with swipe cards for users. The price per standpipe system was approximately \$17,400 ex-GST plus plumbing costs. Ongoing charges for software, customer support, cloud-based server and annual inspection fees totalled \$1,305 ex-GST per annum.
- 12. Example of standpipe controller system:-

- Free standing unit ready for connection by local plumber.
- The frame requires a small concrete pad of 1 x 1m and about 150 mm thick.
- Each user has a swipe card to access the water supply.
- Once the user is provided with access (the light flashes green), the start button opens the motorised valve and the water meter will start recording the usage and logs that against the person linked to the access card.



DISCUSSION

- 13. Changes in water charges by the Water Corporation on rural fixed water standpipes has facilitated a review of how the City manages its standpipe assets.
- 14. It is acknowledged that water is a valuable and scarce commodity, and that access to potable water is important to the community, essentially a human right.

Fire Fighting:

15. Access to standpipes for a fire emergency will remain the same, with all Brigade Bush Fire Control Officers (BFCO's) being issued with a key to unlock padlocks on fire standpipes.

Potable Water Access:

- As stated in the Water Corporation's Frequently Asked Questions (FAQs) document (Attachment 1), Local Governments are able to set the price for on-selling water at their discretion. Charging GST on water is <u>not</u> permitted.
- 17. Consultation with local commercial water carting contractors identified only 2 operators who requested access to City-owned standpipes. The other 2 operators have installed their own standpipes.
- 18. Officers believe that, at this stage, the City can avoid installing costly standpipe control systems by setting up a basic user pays system, similar to the one being operated by the Shire of Augusta-Margaret River. Noting, an electronic standpipe control system, could be installed in the future if the number of community / commercial users increases.

Public Health:

- 19. The City's Environmental Health Officers have advised that potable water carting businesses that transport quantities in excess of 100 litres of water need to comply with the Department of Health's *Guidelines for the Bulk Cartage of Drinking Water* (Attachment 2). The purpose of the guidelines is to ensure that equipment used to collect, contain and transport drinking water does not become a source of contamination which can cause illness or disease.
- 20. The Guidelines for Bulk Cartage of Drinking Water address the following issues:
 - responsibilities of the carrier
 - design, construction, maintenance of containers and fitments
 - selection of drinking water sources
 - collection, transportation and discharge
 - disinfection of drinking water
 - consumer advice
 - record keeping.

- 21. The water carrier is responsible for ensuring that the water provided to consumers complies with the *Australian Drinking Water Guidelines 2004.* This includes the chemical and bacterial quality of the water.
- 22. Potable water carriers must notify the local government in which the vehicles are normally kept, and must register as food business with the local government, prior to commencing operation. The Local Government Environmental Health Officer will undertake an inspection of the vehicle and check safe processes are in place and contamination risks are minimised, prior to issuing a Food Business Registration Certificate.
- 23. It is recommended that Commercial water carting operators who access City standpipes be registered as a food business if the water is intended for human consumption and use (i.e. showering).

Proposed Process:

- 24. **Option 1:** For each load of water taken, approved users would first obtain a standpipe key from the City's Mercer Road depot and later return the key with a completed standpipe record of readings form.
- 25. The standpipe would be accessible during depot office hours only, i.e. Monday to Friday, 7.30am 4.30pm.
- 26. **Option 2:** Alternatively, users could be given a key to access the standpipe at any time and submit their completed standpipe record of readings forms every 2 months to coincide with billing times.
- 27. When the City receives bi-monthly invoices from the Water Corporation, it would on-charge the costs by:
 - a) Equally dividing the annual service charges between commercial operators;
 - b) Allocating the water usage costs based on the litres stated on the record of readings forms completed by each operator; and
 - c) Adding a fee to cover administration and maintenance costs of operating this service for the public.

STATUTORY IMPLICATIONS

- 29. In accordance with section 6.19 of the Local Government Act 1995, changes to fees and charges: If a Local Government wishes to impose any fees or charges after the annual budget has been adopted, it must, before introducing the fees or charges, give local public notice of:
 - a. its intention to do so; and
 - b. the date from which it is proposed the fees or charges will be imposed.

POLICY IMPLICATIONS

- 30. It is recommended that the current arrangements for standpipe use remain in place until a policy position is made by Council.
- 31. The following proposed policy positions are proposed for review:
 - a. **Commercial Standpipe:** Should City-owned standpipes be made available to commercial operators to purchase water? Yes or No.
 - b. **Declared Drought Conditions:** That during a declared Water Deficiency Event (drought) made by the State Government, farmers will be provided access to water from any standpipe at a concessional rate, in accordance with the deficiency declaration.
 - c. **Firefighting:** All standpipes be made available for firefighting. Bush Fire Brigades to be issued a key to unlock the padlocks during a fire incident. Noting farm fire-fighting tanks should be filled from a local water source from the owner's property (eg. dams) and not utilise potable water for that purpose. However, in the event of a fire, farmers can use any standpipe to fill their units.

32. The risk identification and categorisation relies on the City's Enterprise Risk and Opportunity Management Framework.

FINANCIAL IMPLICATIONS

Water Charges

- 33. The City received advice from the Water Corporation that new pricing of water from Councilowned standpipes would come into effect and increase from 1 July 2019.
- 34. Currently, Council approved fee, charges \$2.53 per kilolitre and does not on-sell for profit.
- 35. Annual water service charges have not been on-charged to users in the past.

36. For the Chester Pass Road standpipe, meter number: EK1800463, The City would be charged the following based on current 2019/2020 rates:-

Chester Pass Road - Meter Number: – the old faulty meter was recently re	EK1800463 (formerly meter number EK0700752 eplaced)
40mm meter water service charge	\$1,088.27 annually or \$181.37 bi-monthly (based on 6 meter readings per year)
Water usage charge (per kilolitre = 1,000 litres)	Town Class Step 11 applies which is currently \$6.089 per kilolitre

- 37. Council will be required to amend its fee for the current and future budgets if it chooses to provide water.
- 38. GST must not be charged on the annual service charges or the water use charges. The City could only charge GST on its administration/infrastructure maintenance fee when invoicing community users or commercial operators.

Commercial Water Access Facilities

- 39. If Council chooses to upgrade and / or supplement its water standpipe system by installing controllers at standpipes, the following is proposed:-
 - Access to any designated, metered City standpipe may be controlled with an electronic swipe card system, with all costs being passed on to community and commercial users.
- 40. The City has not set a proposed revised fee yet (*this will happen as part of a budgeting amendment process for the current budget*). However, the rate will not be less than the rate charged by the Water Corporation, which is currently up to \$8.353 per kilolitre depending on the size of the standpipe.

LEGAL IMPLICATIONS

- 41. It is a human right to have access to potable water.
- 42. The entity (Federal, State or Local) responsible for providing access to water is debateable.

ENVIRONMENTAL CONSIDERATIONS

- 43. It is considered appropriate to develop a policy position to ensure that the human right to access potable water for residents not connected to scheme water is maintained or improved, while ensuring that the valuable resource is not wasted.
- 44. The Water Corporation has decided not to decommission the 5 unrequired standpipes identified by the City. Instead, it will cap them to ensure easy access in case of future droughts and major fire events.

ALTERNATE OPTIONS

- 45. Council has three main options to consider:-
 - **Option 1:** Provide commercial access to City-owned standpipes to Commercial water carters on a cost recovery basis plus an administration/maintenance fee; and/or
 - **Option 2:** Provide community / commercial users with access to City-owned standpipes via controlled standpipe infrastructure; or
 - **Option 3:** Not provide community / commercial users with access to City-owned standpipes and refer them to the Water Corporation.

CONCLUSION

46. It is recommended that the Chester Pass Road standpipe meter number EK1800463 be made available to identified commercial operators for the purposes of carting potable water to Albany residents who are not connected to scheme water, while complying with the conditions detailed above.

BACKGROUND

- 1. In 2016 the City of Albany sent a request to dedicate portion of Lot 3663 Unallocated Crown Land as road reserve.
- 2. Due to this land being Unallocated Crown Land, it was allocated for inclusion into the South West Native Title Settlement package.
- 3. As a result of this, the City's proposal was subsequently put on hold pending finalisation of the Settlement, which is now under Judicial Review. This review can potentially further delay City proceedings and operations.

DISCUSSION

4. The Department of Planning Lands & Heritage have requested that the City provide a Council resolution under Section 56 of the *Land Administration Act 1997* and indemnify the State of Western Australia, the Department of Planning Lands & Heritage and Minister for Lands, as is required under the *Native Title Act 1993 (Cth)*.

GOVERNMENT & PUBLIC CONSULTATION

- 5. A Public notice was placed in the Albany Advertiser on 22 November 2016 asking for submission on the proposal.
- 6. The public comment period was open for 45 days with no comments having been received by submission close on 6 January 2017.
- 7. The City also sent letters out to all service providers on 16 November 2016. Five responses were received with no objections to the proposal.

Conditions:

- 1. All development shall occur in accordance with the stamped, approved plans referenced P2190481 and dated XX XX 2019, unless varied by a condition of approval or a minor amendment, to the satisfaction of the City of Albany.
- 2. If the development, the subject of this approval, is not substantially commenced within a period of 2 years from the date of approval, the approval shall lapse and be of no further effect.
- 3. A revised management plan shall be submitted, approved and implemented to the satisfaction of the City of Albany, the revised plans to address the following;
 - Reducing number of guests to eight;
 - Additional measures in relation to pets creating disturbance.
- 4. The operation of the holiday accomodation hereby approved shall be in accordance with the approved management plan, which shall be reviewed and updated at the time of any change of ownership or management, to the satisfaction of the City of Albany.
- 5. The holiday accomodation hereby approved shall not prejudicially affect the amenity of the neighbourhood by, but not limited to, the emission of noise, vibration, smell, smoke or dust to any extent greater than what is to be expected within a residential zone.
- 6. The holiday accomodation hereby approved shall only be used for short stay accommodation, with any single tenant permitted to stay for no more than three months in any twelve month period.
- 7. The operator or manager of the holiday accomodation hereby approved shall maintain an annual register of all guests to the satisfaction of the City of Albany. A receipt book must also be kept.
- 8. Each bedroom utilising beds shall have a floor space of not less than four square metres per person; each bedroom utilising bunks shall have a floor space of not less than 2.5 square metres.

- 7. The application was advertised for public comment for a period of 21 days, with nearby landowners directly notified by letter.
- 8. Three submissions were received during advertising which raised concerns in respect to the proposal. The concerns raised are summarised later in this item.
- 9. Council is now requested to consider the submissions received during the public advertising period and determine whether to grant development approval.

DISCUSSION

- 10. The applicant has provided the following (summarised) outline of how the proposed holiday house will operate:
 - The property will be managed by the landowners, with additional management and maintenance assistance provided from a resident based in Albany.
 - A maximum of eight guests is proposed (originally 12).
 - Parties and functions are prohibited, further to this, excessive noise will result in eviction
 - No functions or parties being permitted that would conflict with residential amenity.
 - Pets are proposed to be permitted if kept outside.
 - Guests and visitors must comply with access and parking regulations provided.

- 11. The main planning concerns raised and the proposed mitigation measures are addressed, as follows;
 - The proposal potentially impacting upon the amenity and character of the area;
 - Concerns in relation the number of guests;
 - The proposed holiday accommodation allowing pets;
 - Existing lighting at the rear of the property being excessive; and
 - Proliferation of Holiday homes.
- 12. The applicant was contacted in relation to the number of guests proposed and has agreed to reduce the number to eight. A condition will be applied for the management plan to include this revision.
- 13. In respect to the amenity and character of the area, it is necessary to consider that the proposal is located within the preferred area for holiday accommodation within the City of Albany Holiday Accommodation Local Planning Policy. It is considered that with the implementation of a suitable management plan as a condition of approval, that the use will not detrimentally affect the character or amenity of the area.
- 14. The keeping of domestic animals is permitted on a residential property. THAT Council in accordance with *State Planning Policy No. 2.6 - State Coastal Planning Policy* resolves to ADOPT the final Emu Point to Middleton Beach Coastal Hazard Risk Management and Adaptation Plan (CHRMAP) including Implementation Plan, Appendices and Summary of Feedback.

BACKGROUND

- 2. The City of Albany (The City) has undertaken development of a Coastal Hazard Risk Management and Adaptation Plan (CHRMAP) to provide strategic guidance on coordinated, integrated and sustainable planning and management for key coastal assets in the Emu Point to Middleton Beach area. The Emu Point to Middleton Beach area has been identified by the community as highly valued for economic, social and environmental reasons.
- 3. Preparation of the CHRMAP has strongly focused on incorporating community and stakeholder values and input, while balancing the need for culturally and economically acceptable outcomes.
- 4. Adoption of the Plan will progress detailed studies, investigations and assist in the development of further work such as the Emu Beach Foreshore Management Plan.
- 5. The report proposes a number of adaptation and resilience measures, including long-term adaptation pathways that the City and its community can adopt to become more resilient to coastal hazards such as coastal erosion and inundation.
- 6. The adoption of the final CHRMAP report is not the conclusion of the project. The report is a strategic document that recommends specific investigations and ongoing monitoring actions to inform periodic review of the plan.
- 7. The final CHRMAP report has been produced in accordance with State Government requirements and responsibilities under Part 3 of the *Planning and Development Act 2005*, which is further outlined in *State Planning Policy No. 2.6 State Coastal Planning Policy (SPP 2.6)*.

8. There are 46 Local Governments responsible for managing coastal foreshore reserves in WA and around 30 Local Governments have completed or are in the process of completing CHRMAPs across WA.

DISCUSSION

- 9. The CHRMAP is based on extensive technical background research and investigations, community and stakeholder values and inputs, recognition of strategic planning and governance interventions available to the City and the need for culturally and economically acceptable outcomes.
- 10. The report identifies the historical experience of coastal hazards along the coast between Middleton Beach and Emu Point and recognises that the City must act proactively to avoid ongoing risk to people and property. Technical studies have identified the potential extent of erosion and inundation for each of the timeframes 2017, 2030, 2050, 2070 and 2120. Using these studies and engagement with the community, this report highlights the assets at risk, which include access to beach, coastal scenery and vistas, coastal vegetation and habitat, dual use path and cafes. Stakeholders indicated that they were willing to pay for protection of significant coastal assets.
- 11. The report also highlights the existing controls available for the City in decision-making, recognising gaps such as a lack of a suitable mechanism to warn private citizens of the existing risk to property.
- 12. Through the CHRMAP process short term recommendations have been identified as:
 - a. Overarching Recommendations: key strategic, statutory planning, and policy or governance interventions that COA will need to implement regardless of the proposed adaption option chosen per asset; and
 - b. Asset Based Recommendations: recommended adaption plan actions proposed for each specific asset, which has been identified as at risk in the short term.
- 13. Five Management Units containing seven (7) highly valued assets are identified in the project area as requiring adaptation in the short term (0-10 years).
- 14. The recommended adaptation option(s) for these assets requiring short-term management were developed in conjunction with the City of Albany, Consultant Team and a Community Advisory Panel. Eleven (11) adaptation options have been recommended for further investigation, they are as follows:
 - a. MU1 Ellen Cove Beach: Sand Nourishment;
 - b. MU2 Foreshore: Avoid Further Development;
 - c. MU2 Big4 Middleton Beach: Staged relocation of assets;
 - d. MU2 Big4 Middleton Beach: Protect Seawall;
 - e. MU3 Griffiths Street Properties: Managed Retreat, relocate assets;
 - f. MU3 Emu Beach Holiday Park and Dual Use Path: Managed retreat of assets in the Southern portion;
 - g. MU3 Emu Beach Holiday Park and Dual Use Path: Renovation/expansion of groynes (geotextile sand container);
 - h. MU3 Emu Beach Holiday Park and Dual Use Path Upgrade existing protection structures;
 - i. MU4 Emu Point Foreshore Reserve: Maintain and enhance nearshore system seagrass regeneration;
 - j. MU4 Emu Point Foreshore Reserve: Revetment and parkland development; and
 - k. MU5 Oyster Harbour Southeast Beach: Sand nourishment.

- 15. Assessment of adaptation options was undertaken with broad stakeholder engagement, using tools such as multi-criteria analysis to illustrate the relative risks, capital and maintenance costs, environmental impacts, social and amenity impacts, reversibility and effectiveness.
- The City conducted a Public Comment Period from 29/05/2019 26/06/2019. The results of this comment period are contained in the Emu Point to Middleton Beach CHRMAP – Public Comment Summary & Response (August 2019).
- 17. As a result of the feedback submissions, the content of the documents was refined and finalised, noting that individual recommendations are subject to further scoping and design to determine exact requirements and cost.
- 18. A separate and standalone Implementation Plan recommends key strategic planning, statutory planning, and policy or governance interventions that are relevant to all assets, including those at risk over the longer-term. The City of Albany will need to implement these options regardless of the final adaptation option chosen per at-risk asset.
- 19. The Final Draft CHRMAP was presented to Council in August 2019 following the Public Comment Period and updated recommendations.
- 20. Following, the document was then circulated to the Project Steering Committee for final review and noted to be accepted.

GOVERNMENT & PUBLIC CONSULTATION

- 21. A Project Steering Group was established in October 2017 to guide the project development.
- 22. The role of the Project Steering Group was to provide technical coastal planning skills to the Grantee and ensure the project progressed in line with milestone reports and progress reports.
- 23. The Steering Group included representatives from project sponsors: Department of Planning Lands and Heritage and City of Albany, as well as other local government agencies and departments, local community friends' groups, local business and tourism operators. This group has been meeting regularly for more than 2 years.
- 24. The function of the Steering Group was to:
 - a. Deliver guidance and oversight on, and make decisions in relation to, all aspects of the Project, including but not limited to:
 - b. Reviewing Project Brief;
 - c. Assess of Tenders (through recommendations of the Tender Assessment Panel);
 - d. Provide discussion on the methodology for each milestone (as required);
 - e. Make recommendations on the project objectives and outcomes;
 - f. Review project deliverables including the Community and Stakeholder Engagement Plan, Issues Paper, draft and final CHRMAPs; and
 - g. Attend meetings as required.
- 25. The Steering Committee provided guidance and oversight however in the event of a dispute, the City of Albany had the final decision.

- 26. The Steering Group meetings occurred on the following dates:
 - a. 21/10/2017
 - b. 13/02/2018
 - c. 22/08/2018
 - d. 19/02/2019

- 28. The City of Albany conducted a formal public advertising period of the draft CHRMAP for 28 days. 125 survey submissions were received and 1 written submission. Reponses have been collated in the *Public Comment Summary & Response Emu Point to Middleton Beach CHRMAP*.
- 29. The CHRMAP was reviewed in light of the submissions received during consultation and a number of modifications were made to address the matters raised.
- 30. Elected Member Briefing occurred on the following dates:
 - a. 13/11/2017 results of Coastal Hazard Mapping and Vulnerability Study
 - b. 31/01/2018 Introduction to CHRMAP process
 - c. 18/02/2019 Proposed Adaptation Options
 - d. 20/08/2019 Draft CHRMAP
- 31. The CHRMAP was also referred to the Department of Planning Lands and Heritage who assessed and noted support for the Plan.

STATUTORY IMPLICATIONS

- 32. State Planning Policy No. 2.6 State Coastal Planning Policy and associated Guidelines is the most pertinent policy to inform and guide decision-making for coastal planning; including managing development and land use change; establishment of foreshore reserves; and to protect, conserve and enhance coastal values.
- 33. The most relevant section of the policy is section 5.5 and deals with Coastal hazard risk management and adaptation planning.
- 34. The CHRMAP Project Area has been included in the Albany Local Planning Strategy (ALPS) as a special investigation area.
- 35. The CHRMAP includes a number of actions which will lead to further amendments and controls being introduced into the Planning framework over the area, these include:
 - a. Disclosure of risk through the planning process.
 - b. Adaptation measures.
- 36. All future strategic and statutory proposals within the CHRMAP area will be required to be considered against the document.

- 37. A full review is recommended to be undertaken within 10 years and in conjunction with ongoing reviews of the City's Local Planning Strategy and Local Planning Scheme.
- 38. The voting requirement of Council is to be Simple Majority.

POLICY IMPLICATIONS

MEETING

39. Should the CHRMAP be adopted and recommendations progressed in the future, Federal and State policies may apply to the project implementation phase.

RISK IDENTIFICATION & MITIGATION

40. The risk identification and categorisation relies on the City's Enterprise Risk and Opportunity Management Framework.

- 42. This project was funded 50:50 by Western Australian Planning Commission and City of Albany. The CHRMAP was completed within the agreed budget allocation.
- 43. The implementation of recommendations of the CHRMAP will be subject to further funding.

LEGAL IMPLICATIONS

- 44. Governments at all levels and private parties (individuals, businesses and the community) each have important, complementary and differentiated roles in managing risk arising from coastal hazards.
- 45. Local government decision making on coastal planning and development is steered by state government policy and legislation.
- 46. There are no direct legal implications related to this report. However, it should be noted that the City is responsible for:
 - a. Local land use planning;
 - b. Significant aspects of environmental management in the coastal zone, including the provision of waste removal and treatment services, and working with state government for the provision of water, drainage and sewerage services
 - c. Land management of coastal reserves and other coast buffer areas; and
 - d. Provision and management of public infrastructure such as roads, recreational areas and parks in the coastal zone.

47. Governments, on behalf of the community, are primarily responsible for managing risk to public goods and public assets which they own and manage.

ENVIRONMENTAL CONSIDERATIONS

48. Implementation of individual recommendations will require further environmental consideration.

ALTERNATE OPTIONS

49. Council may choose not to support the adoption of the CHRMAP.

CONCLUSION

- 50. The City of Albany has undertaken development of a Coastal Hazard Risk Management and Adaptation Plan (CHRMAP) to provide strategic guidance on coordinated, integrated and sustainable planning and management for key coastal assets in the Emu Point to Middleton Beach area. The Emu Point to Middleton Beach area has been identified by the community as highly valued for economic, social and environmental reasons.
- 51. The report proposes a number of adaptation and resilience measures, including long-term adaptation pathways that the City and its community can adopt to become more resilient to coastal hazards such as coastal erosion and coastal inundation.
- 52. It is recommended that Council ADOPT the final Emu Point to Middleton Beach Coastal Hazard Risk Management and Adaptation Plan (CHRMAP) including Implementation Plan, Appendices and Public Comment Summary & Response.
