BACKGROUND

- The objective of the funding program is to deliver support to targeted drought-affected regions of Australia by funding local community infrastructure and other drought relief projects.
- 3. Funding will target infrastructure and other projects that: provide local employment for people whose work opportunities have been impacted by drought, stimulate local community spending, use local resources, businesses and suppliers and provide a long-lasting benefit to communities and the agricultural industries on which they depend.
- 4. The City has coordinated a group of 10 Local Governments from within our region to work in collaboration to seek synergies in project management, economies of scale and to use the combined intelligence and experience of the group to gain the most effective outcome from the funding and also to leverage other funding opportunities.
- 5. The particular community hall and water resources upgrade projects identified to be funded are:
 - Manypeaks Progress Association 2 X Toilet Upgrades;
 - Elleker Progress Association Various Works;
 - Bornholm Kronkup Kitchen Paint and Security;
 - Napier Progress Association Kitchen Upgrade and Re Clad;
 - Redmond Hall Power Upgrade and Child Play Area;
 - Youngs Siding Kitchen and Various Works;
 - Wellstead Progress Association Reinstate Bore;
 - South Stirling Community Association New Works and Bore;
 - Lower Kalgan Community Assn Various Works;
 - o King River Progress Association Electrical and Various Works;
 - o Bores and Tanks Three Locations Emergency Services; and
 - Replace Compostable Toilets at Three Locations.

GOVERNMENT & PUBLIC CONSULTATION

- 6. At the June 2020 OCM, CCS259 it was resolved by Council to endorse the City of Albany's funding application to the Drought Communities Program.
- 7. The funding application was successful and this Council item seeks to incorporate these items into the 2020/2021 budget.
- 8. DCP Grant Programme Guidelines have been followed in the preparation of the funding application, with support and advice about project eligibility provided by the DIRDC.
