- Partners of delegates must travel at their own expense.
- <u>Subject to CEO approval and sufficient provision in the budget</u>, visiting officials of affiliated cities will be afforded reciprocal hospitality including accommodation, civic events and receptions, district tours and visits."

#### **DRAFT FRIENDSHIP AGREEMENT**

"We, the undersigned representatives of the City Assembly of Nichinan in Japan and the City of Albany in Western Australia, declare our mutual will to establish a Friendship Agreement between our two municipalities, with the aim of creating bonds and gaining a wider understanding of our respective municipalities, citizens, community life and traditions.

In support of these ideals, the City Assembly of Nichinan and the City of Albany agree to promote their similar aims and objectives, with the primary relationship to be based on people to people contact, and therefore the respective elected authorities are charged with the responsibility of encouraging the development of greater understanding and the exchange of knowledge and experience in many fields by individuals and groups throughout their municipalities.

By emphasising mutual interests and fostering individual consciousness, the City Assembly of Nichinan and the City of Albany will strive to promote close and friendly relations between the citizens of their two communities."

#### **IN BRIEF**

The City of Albany agree to fund \$403,000 and up to \$400,000 in 2010/11 & 2011/12 respectively to the operation of the Albany Entertainment Centre; and

 The City of Albany enter into further negotiations with the GSDC and agree with the provisions of the MOA until 30/6/2012 and seek to include a provision that the Government will subsidise the operational costs of the AEC beyond the handover date.

#### **BACKGROUND**

- 1. The State Government has drafted a Memorandum of Agreement (MOA) relating to the Albany Waterfront project for Council consideration.
- 2. The initial MOA for the Albany Entertainment Centre (AEC) was executed in September 2005.
- 3. The MOA provided that Landcorp would transfer land excised from the Albany Waterfront project site sufficient in area to construct the Albany Entertainment Centre and curtilage to the City of Albany upon the creation of the new lot.
- 4. In relation to financing, the MOA provided that:
  - a. The City of Albany will contribute \$1 million to the Albany Waterfront project in the 2006-07 financial years. (This payment has been allocated and is currently held in Reserve).
  - b. The City of Albany would contribute \$1.2 million plus any Federal grant monies obtained to the Albany Entertainment and Convention Centre Project, and is responsible for securing any additional required funding. (This amount has previously been transferred).
- 5. A subsequent MOA was executed in October 2007, which had the effect of including the Department of Housing and Works as a key stakeholder in the implementation of the project.

#### **DISCUSSION**

- 6. On 21st September 2010 the Minister for Culture and the Arts, John Day announced funding of \$3.96 million to cover the initial operating costs of the Albany Entertainment Centre (AEC).
- 7. The Minister also announced that the Perth Theatre Trust (PTT) will be responsible for managing the AEC for two years with the ownership of the AEC transferring to the city of Albany from 1 July 2012.
- 8. AEG Ogden (Perth) Pty Ltd has been appointed to manage the AEC, under their existing management agreement with the PTT.
- 9. The Government's funding decision is conditional and subject to the City of Albany (CoA) and PTT formalising an agreement on a range of operational and governance issues.
- 10. These actions have been encapsulated in the 2010 draft Albany Waterfront Agreement.
- 11. The Agreement has been developed in response to the City of Albany's request for State government assistance, and the City has been requested for the Agreement to remain confidential until the document is finalised.
- 12. Council resolved that the draft Memorandum of Agreement be referred to an Elected Members Workshop prior to consideration by Council, and this took place on the 26 October 2010.

#### FINANCIAL IMPLICATIONS

- 13. The City has been requested to fund the AEC opening event and the additional capital items required in the first two years of the AEC's operations up to a value, of \$803,000.
- 14. The General Manager, Perth Theatre Trust, has proposed this be staged in the following manner:

Yr 1	\$403,000
Yr 2	Up to \$400,000

15. The City has committed \$125,000 within its current budget to the construction of the additional car bays, and has funds available within budget to fund the \$403,000 requested.
