3. OPENING PRAYER

Deputy Mayor Wellington asked all present to be upstanding and read aloud the opening prayer:

4. PUBLIC QUESTION TIME

*Ms T Cleeve

Ms Cleeve addressed the Council and asked 'What is the Council's debt ratio?'

The Finance Manager Stan Goodman responded by advising that while he didn't have the exact figure to hand, total debt at the end of the financial year was forecast to be in the order of \$30M and revenue forecast to be in the order of \$34M, hence the ratio was approximately 90%.

Mr Goodman undertook to provide Ms Cleeve with the exact information, which was provided in writing dated 6th July 2007 and is reproduced below:

Item 4.0 continued

The projected City of Albany debt to revenue ratio as at 30th June 2008 will be 88.1%. Total projected debt will be \$29,807,787 with operating income of \$33,833,400.

It should be noted that the total loan amount includes \$8,500,000 of short term bridging funding for City subdivisions and self-supporting loans to community organisations in the amount of \$108,994. The subdivision loan will be repaid from proceeds of the Cull Road subdivision.

If these amounts were to be excluded, the net debt to revenue ratio would be reduced to 62.7%. The City's Five Year business plan indicates that within three years, total City borrowings will be down to \$15,000,000 with a debt to revenue ratio of less than 50%.

BACKGROUND

1. All Gross Rental Value (GRV) properties are revalued every four years. This quadrennial revaluation has been done over the previous 12 months and the new values will be used in rates calculations for 2007/08.

2. The average valuation increase for occupied properties, based on possible annual rental from a third party, was 30%. The average value of vacant land, which is based on the capital value of the land, was 190%.

STATUTORY REQUIREMENTS

3. Section 6.36 of the Local Government Act (1995) requires that a local government give local public notice of its intention to levy differential rates, make available a document describing the objects of and reasons for each differential rate, invite public submissions on the proposal, allow at least 21 days for submissions, and consider any submissions before imposing a differential rate.

COMMENT/DISCUSSION

7. The City proposes to levy differential rates for the 2007/08 financial year. Details of the proposed rates are:

Description	Actual Rate '06/07	Proposed Rate '07/08
Gross Rental Value (GRV)	00/07	07/00
Occupied properties	11.2366	9.0031
Vacant land	11.2366	4.5960
Unimproved Value (UV)	0.5424	0.3779
Minimum Rate	\$508	\$508

- 8. It should be noted that rates in the dollar have been reduced to compensate for the revaluation of all Albany properties by Landgate (the Valuer General). Whilst the value of occupied GRV properties increased by an average of 30%, the vacant land valuation, which is based on the capital value of the land, increased by an average of 190%.
- 9. The purpose of the differential rate for vacant land is to ensure that the average rates burden carried by owners of vacant land is consistent with previous valuations. When such properties are developed, the higher GRV Occupied Rate will be imposed, reflecting the increased level of City services.

10. It is proposed that in accordance with the statutory requirements associated with the levying of differential rates, electors and ratepayers be invited to make written submissions prior to 27th July 2007 commenting on the proposed differential rate. Council will consider submissions at the budget adoption meeting on 31st July 2007.

Reason:

Councillors supported the funding of the two school chaplains but did not want that ongoing funding to reduce the level of available funding for youth based grants. Councillors were also reluctant to support any further increase in rates and felt the reallocation of funds from the Mayoral Regalia account was the best option.

THAT the \$3,500 allocated for the Keep Albany Beautiful Committee be deleted.

Reason:

The Keep Albany Beautiful Committee has not been active in recent years and the Committee has adequate funding to implement any activities during the 2007/2008 financial year.
