BACKGROUND

- 1. Council has received a response from the Minister for Planning and Infrastructure that she requires the conduct of a Citizens Jury to assist in the determination of approval or otherwise of Amendment No. 134.
- 2. The process of the Jury is set out in the attached draft Memorandum of Understanding to be agreed upon between the City and the Minister.

STATUTORY REQUIREMENTS

3. The Minister for Planning and Infrastructure has total power to approve or disallow the rezoning of the North Road Site. No appeal provisions exist.

POLICY IMPLICATIONS

4. There are no policy implications relating to this item.

FINANCIAL IMPLICATIONS

5. The Minister for Planning and Infrastructure will fund the Citizens Jury.

STRATEGIC IMPLICATIONS

6. There are no strategic implications relating to this item.

COMMENT/DISCUSSION

- 7. Council has essentially three options in terms of the response from the Minister:
 - a) The first option it to accept the offer of the Citizens Jury and commence the process in conjunction with the Ministry for Planning and Infrastructure;
 - b) The second option is to accept the offer of the Citizens Jury with amendments to the Memorandum of Understanding that may better suit Council's requirements. Should the Minister not agree with the amendments then this consideration could lead to the amendment proposal being refused; and
 - c) The third option is to reject the Citizens Jury concept which would lead to the amendment proposed being refused.

RECOMMENDATION

Option 1:

That the Citizens Jury process, as defined by the Minister for Planning and Infrastructure, be accepted and actions commenced immediately to progress the matter.

Option 2:

That the Minister for Planning and Infrastructure be requested to accept the amendments to the process of the proposed Citizens Jury and actions commenced immediately to progress the matter.

Option 3:

That the Citizens Jury concept be rejected and the Minister for Planning and Infrastructure be advised accordingly.

MEMORANDUM OF UNDERSTANDING BETWEEN MINISTER FOR PLANNING AND INFRASTRUCTURE AND CITY OF ALBANY

ON THE ALBANY ADMINISTRATIVE CENTRE

Background

Professional planning advice is to maintain the primacy of the CBD as an administrative centre. However, the site preferred by the Albany City Council is outside the city centre. To resolve this issue, it is suggested that a representative, informed, community group should play a primary role.

Memorandum of Understanding

Between the Minister for Planning and Infrastructure and the City of Albany

- The community consultation process will address the following question:
 - Is the North Road Site an appropriate location for a Council Administration Centre?
- The community consultation methodology will be a Citizens' Jury;
- The Citizens Jury will be facilitated by Dr Janette Hartz-Karp, a consultant experienced in facilitating Citizen's Juries;
- The Citizens Jury hearings will be completed over one day;
- The process will be overseen by an Advisory Group consisting of a member of the Albany City Council, a representative of the WAPC, a representative from the Ministers' Office, and two community representatives (one supporting a site in the CBD, one supporting a site outside the city centre), The City of Albany reserves the right of veto over the selection of the community representatives;
- Citizens Jury representatives will be elicited from a WA Electoral Commission random sample;
- The Advisory Group will determine the criteria for selection (eg half female, half male; half with interested within the CBD, half from outside, no people from the same family or living on the same street):
- An independent person will select the Jury according to the agreed upon criteria. Between 12 15 jurors will be selected;
- Expert Witnesses will be chosen by the Advisory Group;

Recommendation Cont...

- Expert Witnesses will be given sufficient time (2 3 weeks) to prepare briefs to present to the Jury;
- The public will be allowed to attend the first part of the Jury hearings where the Expert Witnesses present their briefs and are questioned by the Jurors;
- ½ hour will be allocated to allow members of the public to put their written questions to the Expert Witnesses;
- Following Expert Witness examination, all members of the public will leave, enabling the Jury to deliberate in camera;
- The outcome of the Citizens' Jury will be written in a brief report that will be presented to the Advisory Group;
- All parties will abide by the Jury's recommendation;
- The Jury will aim to achieve a consensus decision. A consensus decision will be defined as finding common ground a solution that all members can live with even if it is not their best option;
- If the recommendation is in support of the North Road site, the Minister will grant final approval to the amendment to facilitate the use of North Road for this purpose;
- If the Jury is unable to reach consensus, then a 2/3 majority vote will be definitive;
- During this process, any issues of contention regarding the process will be submitted to the Advisory Group for their deliberation and will not be discussed in the media.
