#### TABLED ADDRESS BY MS JILL BOSTOCK

Special Council Meeting 28 June 2012

Meeting called in response to Faileen James public announcement that she is parting company with the City of Albany.

Mayor and Councillors I thank you for the opportunity to speak. It saddens but does not surprise me that this City is faced with another crisis. Your ongoing difficulties are the inevitable consequence of all that has gone before. The problems are not a result of an isolated incident but a combination of factors that individually might have been managed but have been overwhelming in their entirety. These problems have served to highlight fundamental flaws and deficiencies in all levels of Government in WA and I believe the people of Albany have been let down at every level. It is the failure of proper accountability, proper checks and balances, proper support and back up that has allowed the situation to deteriorate to such damaging proportions. Whilst there have been failures of Council, the City's CEO, the Department of Local Government and other regulatory authorities are also culpable.

An organisation will flounder when unethical behaviour is ignored, when secrecy and protection of the establishment takes precedence over truth and honour. It is not possible to build on such foundations; difficulties will compound and the situation inexorably deteriorates.

The enemies of good governance are arrogance, complacency and an inability to self examine, to acknowledge mistakes and learn from them. It has been said before "mistakes are the inevitable consequence of human endeavour; it is what we do with them that matters." It was for this reason I felt compelled to address you this evening.

This crisis is not to be feared. It is an opportunity for this Council to turn things around, to do the right thing and set the City on the difficult but honourable road to recovery. This crisis is almost identical to that involving our last CEO Paul Richards, Councillors DO NOT MAKE THE SAME MISTAKE AGAIN.

I implore you to take this matter slowly and guard against any precipitous decisions.

Do not be influenced by those arguing for commercial expediency, you are not a commercial enterprise; public servants have much greater responsibilities.

It is of the utmost importance that all Councillors read the Legal Advice, from Minter Ellison on 6 April 2010; it is clear in its delivery, detailing the appropriate action to ensure the best interests of the community and is highly pertinent to the case before you this evening.

Follow that advice, ensure you have all the facts, do not give way to false claims or pressure from others and listen to your own moral compass. Do what is right, manage this crisis to protect the City and set it firmly in a new direction of honest, open accountable leadership that will earn the respect of the community.

TABLED ADDRESS BY MR MERVYN LEAVESLEY

Good evening Mayor and Councillors

My address tonight is entirely my own opinion.

At the outset I wish to state that I have great sympathy for the new Councillors I know what a steep

learning curve it is.

However by any measure Council you have failed.

You have failed the residents - Council speaks with its decisions. Time and again you have made

decisions and then almost as an afterthought put the issue out for public consultation. I speak of

third party right of appeal, trading hours and your meeting rules or more commonly known as

standing orders. Your new standing orders are a recipe for executive rule and seek to isolate council

from public scrutiny.

You have also failed residents by not properly monitoring the delivery of last year's budget which is

evidenced by the amount of financial variances. I have searched the strategic plan to see where it

says that the financial welfare of the legal profession of Western Australia is a responsibility of the

City of Albany but I can't find it. But given the amount you have spent on legal fees this year it must

be there somewhere.

You have failed yourselves, staff and residents by revoking policies without replacement and

delegating important oversight functions of council to the CEO. The consequences of which have

become evident to many of you, but too late.

Council only has one employee - the CEO. It is clear that the situation we now face did not happen

overnight. It has been plainly evident for many many months that there were at least causes for

concern. But it would seem, if what we hear is true, that you have manifestly failed to even meet the

terms of the contract with the CEO let alone protect the interests of ratepayers by operating the

standard employment practice of performance management.

For the two years that I was on Council I saw no evidence of Council acting as a proper governance

body. Nothing I have seen to date persuades me that anything has changed since.

Council has been driven by hidden agendas and political imperatives rather than due process.

Having said that I believe we have all collectively failed and we must all accept some responsibility.

Ultimately however the responsibility for where this City finds itself today is Minister Castrilli's.

Two years ago our Member of Parliament called for an enquiry into the City. Two years ago a

meeting of electors also called for an enquiry. Two years ago a consultant hired by council at great

expense under the instruction of the Minister I might add, also called for an enquiry and two years

ago this council by an absolute majority endorsed the resolution of the electors meeting and called

for an enquiry.

As we all know to our cost the Minister refused.

Minister Castrilli's has let our community down badly resulting in the community's almost total loss

of confidence in the function of our local government. I have no confidence that the Minister will

even act now. He seems incapable of making any decisions.

The City of Albany is not only a level of government but also the biggest enterprise in town. It is only

with community confidence in the open, accountable and effective running of the City's operations

that we can hope to prosper.
