#### STRATEGIC IMPLICATIONS

#### In Brief:

- The Joint Standing Committee on Delegated Legislation (the Committee) is unable to wait to receive undertakings after the next scheduled council meeting scheduled to be held on 24 November 2020.
- Council is requested to consider the undertaking as an urgent, noting urgent being defined in the City of Albany Standing Orders Local Law meaning something which is a matter of public or administrative importance that has to be dealt with prior to the next ordinary meeting.

#### RECOMMENDATION

**SCM019: RESOLUTION** 

**VOTING REQUIREMENT: ABSOLUTE MAJORITY**

The Council of the City of Albany resolves to undertake to the Joint Standing Committee on Delegated Legislation that the City will:

- 1. Within six (6) months, amend the City of Albany Jetties, Bridges, Boat Pens and Swimming Structures Local Law 2020 to:
  - a. in clause 2.2, delete each occurrence of the words 'the jetties' and replace them with the words 'a jetty';
  - b. in clause 1.5, insert a definition of 'Land';
  - c. in clause 1.5, insert a definition of 'Ellen Cove Jetty';
  - d. in clause 2.3(2), delete '3.2(2)(a)' and insert either 3.4 or 3.5 (whichever the City considers applicable);
  - e. amend either clause 3.9 or 4.7 to remove the inconsistency between the time frames in which a vessel must be removed;
  - f. in clause 2.19, delete the word 'filth';
  - g. delete clause 4.4;
  - h. in clause 5.2(3), insert the words 'by resolution' after the word 'decide'
  - i. insert an exemption to the prohibition of animals in or on any part of the pen system for assistance animals;
  - j. make any other necessary consequential amendments).
- 2. Until the Local law is amended in accordance with undertaking 1:
  - a. Not enforce the Local Law in a manner contrary to undertaking 1.
  - b. Where the Local Law is made publicly available, whether in hard copy or electronic form (including on the City's website), ensure that it is accompanied by a copy of these undertakings.

#### BACKGROUND

- 2. The Joint Standing Committee on Delegated Legislation's (the Committee) wrote to City of Albany on the 4 November 2020.
- The short time period for response is due to the approaching final sitting day of the Parliament, which is anticipated to be 26 November 2020. Any disallowance motions which remain on the Notice Paper on the last day of Parliament are required to be voted upon on that day.
- The Committee hopes to receive the undertakings in sufficient time to remove the Notice of Motion to Disallow from the Notice Paper, so that Disallowance of the Local Law is not required
- 5. The Committee is unable to wait to receive undertakings after the City's next scheduled council meeting on 24 November 2020.

#### DISCUSSION

- 6. The latest possible extension for an undertaking that the Committee can provide is this Friday, 13 November 2020.
- 7. If the Committee is not provided with an undertaking by COB on this day (Friday, 13 November 2020), the Committee will proceed with the printing and tabling of its disallowance report.
- 8. In regards to the Notice of Motion from Committee to disallow the local law, it should not be taken that the Committee has resolved to recommend disallowance of the Local Law at this stage.
- 9. The giving of a protective Notice, which is facilitated by the proposed undertaking, allows both the Council and the Committee additional time to deal with and respond to the issues identified.
- 10. Council is requested to resolve to make the undertaking detailed in the Responsible Officer's Recommendation.

#### **GOVERNMENT & PUBLIC CONSULTATION**

11. Consultation will be conducted during the local law amendment process, which will occur within the next 6 months.

#### STATUTORY IMPLICATIONS

12. If Council resolves not to approve the undertaking the local law will be disallowed.

- 18. This is because, pursuant to section 2.8(1)(d) of the Local Government Act1995, the Mayor speaks on behalf of the local government to the Parliament of Western Australia.
